- (A) The board shall elect a president the university to hold the at its discretion, in accord with its authority set for in section 3359.03 of the evised Code. The following procedures shall serve to guitthe selection process, unsersevised as provided herein.
 - (1) In recognition of the letimate concerns and interests faculty, staff, academic and senior administration, studtes, alumni and community leaders, the search committee will involve such appropriate ctitusencies in the search process as follows:
 - (a) Prior to the invitation for nominations or applications of candidates, the presidential advisory and screegi committee shall offer university constituency groups the opportive to provide input concerning the proposed criteria, process and scheduling for the earch process. The representative constituency and advisory groups manyclude, but are not limited to a representative from: the council of deandepartment chasi; faculty senate; senior administration; constct professional advisory committee (CPAC); staff employee advisory committee (SEAC); university ocuncil; the Akron chapter of the American association of university of fessors (Akron AAUP); students, and community leaders.
 - (b) The board will consider the recommetinates from all constituency groups, but retains the final authority to determine the criteria, process and schedule for the search.
 - (2) Pursuant to the bylaws of the boardtroustees, the chairperson of the board shall name four voting trustees as a presideration and screening committee with the following responsibilities:
 - (a) To make initial androgoing recommendations to the footnmittee regarding the criteria, process, and scheduling foe search for the president;
 - (b) To recommend executive search firms **co**nsideration by the full committee; and
 - (c) To conduct those activities related the search as may be assigned by the chairperson of the search committee.
 - (3) The presidential searcommittee shall consist of:
 - (a) The entire board of trustees, includistandent trustees and advisory trustees, convened as a committee of the whole; and
 - (b) The elected leader (i.e. presiden**tha**ir) of the following constituency groups:
 - (i) University council;
 - (ii) Faculty senate;

- (iii) CPAC;
- (iv) SEAC;
- (v) Undergraduate student government; and
- (vi) Akron AAUP.
- (c) Members of the search committee who are not members of the board of trustees shall be required to execute a confidentiality agreement as a condition of participating on the search committee.
- (d) Members of the searchmomittee shall participate in discussions and meetings of the presidential search committee and hall have access to all presidential search materials.
- (4) The search committee shall recommend downsensus those individual(s) to be considered for employment as president by the board of trustees.
- (5) The foregoing proceduresrfthe selection of the presidt by the board of trustees shall not be construed to limit, rectly modify or relinquish any authority, responsibility, or discretion of the botato employ the president and govern the university consistent with the powers conferred upon the board by law. The board has the final authority to select and empthe president. Notwithstanding anything herein to the contrary, these procedus ball not be deemed to be mandatory, but shall be considered directory in natural, may be revised, in whole or in part, upon a majority vote of the board of trees at any regular or special meeting, without the necessity of prior notice thereof.
- (B) The president is the executive head of all university colleges, branches, schools, and departments and thus, responsible for gensuplervision of all itsinterests. Within general policies of the board, the presidentall lead in fostering and promoting education, instruction, researand scholarly activity, anduplic service asts primary aims. Each year the presidentall submit to the board report on the institution's activities, plans, current and future needs of other relevant data. The president shall attend all meetings of the trustees and dress to them matters of institutional importance. The president is the officimedium of communication between the university, the board and its committeness, seesing the exclusiving to transmit proposals from the faculty and affreither as a group as individuals to the board. This exclusive right of the president shall not abridge the right of trustees to communicate directly with faculty, staff, other employees of the university; and, no employee shall incur any penalty or same tiwhatsoever in connection with such communications.
- (C) By virtue of administrative assignment, three-sident is a member of the faculty senate and of each college faculty and thus, may single at every meeting thereof, if the president so wishes. The pindesnt shall appoint all committees of the faculty senate unless their memberships are designated by rule. The president shall see that measures of the faculty senate, which have been proper unless to and approved by the board,

are implemented and shall ensure that directives of the board relative to internal administration are carried out.

- (D) The president has authority in all mattersstudent discipline in accordance with the rules and regulations of the board. The presidshall oversee preparation of the annual budget and advise the board on all financialters; shall preside commencement and all other public academic occasions; and llsbanfer such appropriate degrees and honors of all colleges and schools as are granted by the institution. The president shall have authority and responsibility to overest intercollegiate latetics and ensure compliance with NCAA and conference rules. The president shall oversee and foster relationships with legislative representative community, and mucripal leaders, state and national higher education fficials, professional assizations, other educational institutions, business leaders, and otheriovas publics of the university and higher education. The president shall assume a primale in fund raising on behalf of the university.
- (E) The board delegates authority to the presidenthe president's designee(s) to employ, set compensation for and remove all full-time administrative officers, faculty, contract professionals and unclassified staff mensioenther than those individuals whose employment is pursuant to personal multi-year employent agreement, and all part-time employees and classified that Any authority or respoints lity of the president may be delegated by the president to any other time administrative officers, members of the faculty or contract professionals of time versity, subject to any limitations set forth by action of the board of trustees. Delegatof appointing author or responsibility shall be in writing and shall be reported the board of trustees by the president.
- (F) The president is authorized and empowered promise, adjust, and settle any and all claims, actions, causes of action, demandsts, expenses, and any and all other damages in connection with any lawsuit filled or against the university in an amount not to exceed two hundred fifthousand dollars, upon such terms and conditions as the president shall deem reasonable and best. All such settlements shall be made in privileged consultation with the chair of the ard of trustees, the chair of the finance and administration committee the board of trustees, athe general counsel. All such settlements shall be subject to any necessapproval of the attorney general and the court in which the action is pending, andch other requirement

(H) Subject to the authority of governmentsted by law in the board of trustees, the authority and responsibility for the internadiministration of the university is delegated to the president of the university of Akrondshall in fact be exercised by the president. The president may consult extensively with
